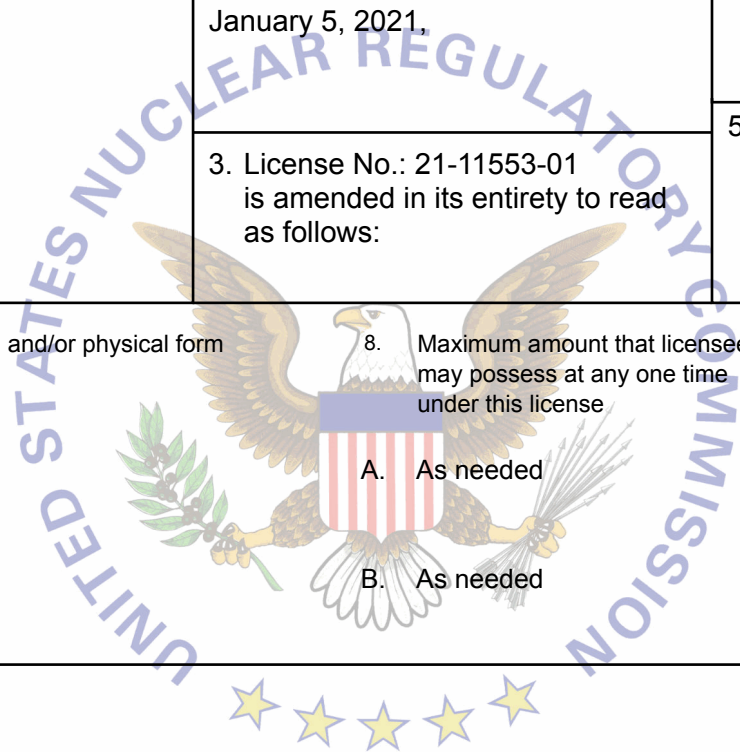


MATERIALS LICENSE
