Pursuant to 10 CFR 35, the current NRC License will fall under the Saint Francis Healthcare System License (License No. 24-00158-03) that will provide oversight to Black River Medical Center effective August 12, 2019. Black River Medical Center hereby requests the RAM License No. 24-32383-01 to be transferred to Saint Francis Healthcare System.

1. The **physical location** of the hot lab and the Nuclear Medicine department is still in the same place, the different mailing addresses were at the request of the Postal Service.

The new name of this facility will be; Saint Francis Outpatient Center of Poplar Bluff.

The purchase of Black River Medical Center's assets, including all Imaging assets, and all Nuclear equipment and hot lab in its entirety was completed by Saint Francis Medical Center in Cape Girardeau, Missouri on August 12, 2019.

2. No changes in current personnel or duties related were made to the licensed program.

3. No changes in the current contamination/decontamination, status of calibrations, leak tests, area surveys, wipe tests, training, quality control or related records have been made. The Radiation safety program will stay in compliance, and staff will meet at the Saint Francis site in Cape Girardeau.
4. The current facility equipment, calibrations, leak tests, area surveys, wipe tests, training and quality control records are still maintained and up to date. There has been no contamination and decontamination is not needed. The Radiation Safety Program will merge meetings with the Saint Francis program.
5. Black River Medical Center and Saint Francis Medical Center do not have Decommissioning Financial Assurance.
6. All records concerning a safe and effective decommissioning of Black River Medical Center will be completed with Saint Francis Medical Center.
7. All parties are aware of the licensed material and activity and will be held responsible accordingly.
8. Saint Francis Medical Center will abide by all constrains, condition, requirements, and representations, and commitments of the transfer.
9. Saint Francis Medical Center is prepared to assume and is financially qualified to conduct normal operations.
