The purpose of this e-mail is to transmit a request for information (RFI) in support of an in-office review of recent changes to Wolf Creek's Emergency Plan and an implementing procedure which were submitted as a summary document in mid-March 2021 (ADAMS Accession No. ML21098A054). The details of the requested information are attached.

The in-office review will be conducted using IP 71114.04 and it is my intention to complete this review by the end of the 2nd Quarter for documentation in this quarter's report.
