This refers to your license amendment request dated March 9, 2021. Please find enclosed Amendment No. 20 removing the storage location at 1800 Congress Street, Fairfield, CT. All facilities at that address previously used for licensed activities may be released for unrestricted use. This also updates your mailing address. A note was entered into our database indicating that records will be maintained at 202 Senate Avenue, Camp Hill, PA.

An environmental assessment for this action was not required, since the actions are categorically excluded under 10 CFR 51.22(c)(14) and (c)(20).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. You will be periodically inspected by the NRC.
