Dear Mr. Shaheen:

Enclosed is Amendment No. 21 to your NRC Material License No. 21-17158-02 in accordance with your request dated March 11, 2021.

Please note that your request to decommission your facility located in Bay City, MI was not approved with this amendment request as it could not be confirmed that all licensed material had been removed from the premises. This decision does not preclude Soil and Materials Engineers, Inc. from submitting a new amendment request with all required supporting information at a later date.

The NRC staff have reviewed your final status results for your former location of use located at 4705 Clyde Park Ave. SW, Grand Rapids, MI. Based on its review, the NRC staff has concluded that all licensable radioactive material has been removed from the facility and residual radioactive material attributable to licensed activities does not exceed current NRC criteria. Based on these conclusions, no further remediation or actions are required with respect to NRC-regulated material at this facility.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.
