Please note that although your license expired on October 31, 2020, our office is in receipt of your September 17, 2020 renewal application. Our review is ongoing; our office will let you know if anything else is needed to complete our review. The NRC's September 30, 2020 timely renewal letter extends the license date until the renewal application review is completed.

Please review the enclosed document carefully, and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. NRC Region III Office at 630-829-9887, so that we may provide appropriate corrections and answers.

An environmental assessment for this action is not required, since this action is categorically excluded under Title 10 of the *Code of Federal Regulations* (10 CFR) Section 51.22(c).

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

The enclosure to this letter contains sensitive security-related information. When separated from this cover letter this letter is uncontrolled.
