Dear Mr. Rhoades:

The Region I Field Office, NRC Office of Investigations (OI), initiated an investigation (Case No. 1-2019-007) on April 19, 2019, to determine whether a security supervisor at Three Mile Island Nuclear Generating Station (TMI) was discriminated against by management for raising a nuclear security concern. Based upon documentary and testimonial evidence developed during the OI investigation, the NRC did not substantiate that the supervisor was subject to discrimination.

Please note that final NRC investigation documents, such as the OI report described above, may be made available to the public under the Freedom of Information Act (FOIA) subject to redaction of information appropriate under the FOIA. Requests under the FOIA should be made in accordance with 10 CFR 9.23, Requests for Records.
