Enclosed is Amendment No. 4 to your U.S. Nuclear Regulatory Commission (NRC) Materials License No. 21-32577-01 in accordance with your April 22, 2021 letter requesting to add Michael William Warren, M.D. as an authorized user (AU) listed on your radioactive materials license, and withdrawing your March 1, 2021 request to add Gopi Krishna Nallani, MBBS, as an AU. Your April 22, 2021 and March 1, 2021 letters are available electronically from the Agencywide Documents Access and Management System (ADAMS) at Accession Nos. ML21123A018 and ML21069A309, respectively.

Please note that we have generated this license using the NRC's electronic Web-Based Licensing (WBL) system. Please also note that we have updated License Condition No. 10, to align with the current standard NRC location-of-use license condition, and have deleted former Condition No. 13 in accordance with current NRC policy to include the reference to 10 CFR Part 71, "Packaging and Transportation of Radioactive Material," in the preamble, on page 1 of the license.

Please review the enclosed document carefully, and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. NRC Region III Office at 630-829-9892 so that we may provide appropriate corrections and answers.

An environmental assessment for this action is not required because this action is categorically excluded under Title 10 of the *Code of Federal Regulations* (10 CFR) 51.22(c).

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation; or imposition of a civil penalty; or an Order suspending, modifying, or revoking your license as specified in the NRC Enforcement Policy. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance that NRC expects of its licensees.
