Dear Ms. Kritzman:

This refers to the renewal license application for Heart Cardiology Consultants, P.C., NRC License No. 21-32278-01. We reviewed the application in accordance with NUREG-1556, Volume 9, Revision 3 and Volume 20, Revision 1 and will need the following.

1. The current license authorizes two locations of use. There were some discrepancies in the application: the provided NRC Form 313 listed one location of use but Item 8.3 listed two locations of use; Form 313 listed a suite number for the facility at 22250 Providence Dr., Southfield, Michigan as stated in the current license but no suite number in Item 8.3. Please provide a clarification.
2. Based on Section 4.7.2.3 of NUREG-1556, Volume 20, Revision 1, please provide contact information (i.e., work phone number, email address, and facsimile number) for the Radiation Safety Officer (RSO).
3. There were indications of the squared footage for each area in the diagram for the facility at 1225 South Latson Road, Howell, Michigan; however, we could not clearly read them. Please provide a readable diagram with the dimensions or scale and indicating the north direction on the diagram.
4. It appeared there was a typographical error in Section 8.11, "Waste Management". The commitment should say "We have developed and will implement and maintain written waste disposal procedures for licensed material, in accordance with 10 CFR Part 20.1101, that also meet the requirements of the applicable section of 10 CFR Part 20, Subpart **K** and of 10 CFR 35.92". Please correct and resubmit this statement.

To continue review of your application, we request that you submit your response with date and authorized signature to this correspondence within 30 calendar days from the date of this correspondence. In your response, please refer the license number, docket number and Mail Control No. 623934. We will assume that you do not wish to further pursue this licensing action if we do not receive a reply within the specified timeframe noted above.
