SUBJECT: RESPONSE TO NUCLEAR REGULATORY COMMISSION INSPECTION REPORT

030-39024/2020-001 AND NOTICE OF VIOLATION

Dear Mr. Casanueva:

On March 24, 2021, the U.S. Nuclear Regulatory Commission (NRC) cited Techcomp, USA, dba Scion Instruments, for a violation involving the failure to provide adequate instructions to end users of exempt devices. NRC Inspection Report 030-39024/2020-001 with enclosed Notice of Violation (Notice) required you to reply in writing in 30 days (NRC Agencywide Documents Access and Management System (ADAMS) Accession ML21078A456). In a letter dated April 16, 2021, you provided your reply to the Notice (ML21119A242), and additional clarification was provided in an email dated April 30, 2021(ML21123A243).

After reviewing the information provided in your reply to the Notice, we have concluded that your corrective actions appear to adequately address the regulatory non-compliances described in the Notice. We will review your implementation of these corrective actions during a future inspection to determine whether full compliance has been restored and whether compliance will be maintained.
