This refers to your license amendment request dated March 22, 2021. Please find enclosed Amendment No. 11 authorizing the Cobalt-57 sealed source you requested and removing Lauren Troia and Nancy Stevens as authorized users. Please note that the activity of the source you requested is listed on your license as the maximum activity allowed per the Sealed Source Device Registry Sheet and not the activity included in your request.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license.
