

A written notification to your radioactive materials regulatory agency for the transfer of exit signs is required. The notification must be either be made to the US Nuclear Regulatory Commission (NRC) and/or an Agreement State authorized to implement the NRC regulations. You can determine if you are in a NRC or Agreement State by going to <http://www.crcpd.org/Map/> and clicking on your state. Below the address listed, it will specify if that state is an Agreement State. If this not specified, then the state does not regulate transfer of exit signs and is considered a NRC State.

Use this general license transfer notification if you are in a NRC State. If you are in an agreement state, just insert your state radiation agency address obtained from the website referenced above. The transfer notification is required to be filed no later than 30 days after the transfer to Curie. You may use the date the shipment is received by Curie as the transfer date.

Use the completed and approved Curie exit sign inventory as the backup and attachment to the transfer notification. If you are a specific licenses, refer to your license for transfer requirements. Contact Curie Customer Service at 505.888.9392 with any questions.

Note that if you are transferring general licensed luminous safety devices for use in aircraft (10 CFR 31.7) that a notification is not required.
