From April 27 - 29, 2021, the U.S. Nuclear Regulatory Commission (NRC) staff conducted a security inspection at the Rhode Island Nuclear Science Center Materials Testing Reactor. The inspection results were discussed on April 29, 2021. The enclosed report documents the inspection results.

The inspection examined activities conducted under your license as they relate to security, compliance with the Commission rules and regulations, and with the conditions of your license. The inspector reviewed selected procedures and records, observed activities, and interviewed personnel. Based on the results of this inspection, no security concerns or non-compliances with NRC requirements were identified. No response to this letter is required.
