- 2. <u>Background</u>: In accordance with reference (b) contract for dismantlement and disposal of the Surface Ship Support Barge (SSSB), APTIM Federal Services, LLC provided reference (a) to NAVSEA (PMS 312) for review and acceptance. Reference (a) provides a Transport Plan for movement of the SSSB from Norfolk VA, to Alabama Shipyard in Mobile, AL.
