Enclosed is your U.S. Nuclear Regulatory Commission (NRC) Materials License No. 10-29283-02, in accordance with your license application, dated February 16, 2021.

Additionally, your license amendment request dated March 2, 2021 has been reviewed as part of this licensing action. Additional information relating to continuing training and experience per 10 CFR 35.59 for Dr. Aslam was requested on April 23, 2021 and again on May 3, 2021. As additional, qualifying, information was unable to be provided at this time this amendment could not be processed as requested and has been closed. Per our discussion on May 20, 2021 this does not preclude you from resubmitting your request when additional supporting information is available.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.
