#### **SUMMARY**

The U.S. Nuclear Regulatory Commission (NRC) continued monitoring the licensee's performance by conducting a security baseline inspection at River Bend Station, in accordance with the Reactor Oversight Process. #### **INSPECTION SCOPES**

Unless otherwise noted, baseline security inspections were conducted in accordance with the appropriate portions of the inspection procedures (IPs) in effect at the beginning of the inspection. Samples were declared complete when the IP requirements most appropriate to the inspection activity were met consistent with Inspection Manual Chapter 2201, "Security Inspection Program for Commercial Nuclear Power Reactors." The inspectors reviewed selected procedures and records, observed activities, and interviewed personnel to assess licensee performance and compliance with Commission rules and regulations, license conditions, site procedures, and standards. #### **SAFEGUARDS**

#### 71130.05 - Protective Strategy Evaluation

The inspectors evaluated the licensee's protective strategy and performance evaluation program. The inspectors observed two licensee annual force on force exercises. The initial sample for this inspection procedure was completed during the September 2020 inspection. Due to the Public Health Emergency, the final sample was delayed until the licensee could safely perform their protective strategy exercise. The final sample was accomplished in May 2021 when the licensee performed their protective strategy exercises. The following elements were evaluated:
