On May 5, 2021, the Nuclear Regulatory Commission (NRC) conducted a live virtual meeting concerning the H. B. Robinson Steam Electric Plant. The purpose of the meeting was to provide opportunities for the public to discuss the annual assessment for the period of January 1, 2020, through December 31, 2020.

In response to the COVID-19 coronavirus and updated Federal Government guidance on travel and social distancing, the meeting was held remotely through the Microsoft Teams application. Additionally, a call-only telephone bridge line was available. The meeting was conducted from 3:00 PM to 4:00 PM local time. Meeting attendees consisted of representatives from the NRC, Duke Energy, South Carolina Department of Health and Environmental Control and members of the public. Due to the nature of the meeting, no official list of attendees is included. NRC staff were available for questions following each presentation. There was minimal interaction with the public which was consistent with the typical annual assessment meetings conducted near the station.
