Subject: Concerning the NRC’s RAI Sent May 3, 2021

Discussion: Mr. vonEhr had been attempting to make contact with Mr. Brian J. Festa regarding the timely completion of the May 3, 2021, RAI. Mr. Festa completed a response to the RAI and submitted this on June 3, 2021, but two of the answers did not adequately satisfy the original RAI (specifically Item 1.b and 3). Mr. vonEhr made contact with Mr. Festa on Friday, June 4, 2021, and discussed with him the two inadequate answers provided in his response to the RAI, and clarified Mr. Festa’s understanding for the questions of concern.

Action: Mr. Festa will resubmit his June 3, 2021 response to the May 3, 2021 RAI, with amended answers to Items 1.b and 3.

Note: the action has until June 20th to maintain timeliness with the 90-day licensing metric for routine amendments.
