The Nuclear Regulatory Commission recently published a Federal Register Notice announcing our intent to submit an information collection request to the Office of Management and Budget (OMB) for Part 54 of title 10 of the *Code of Federal Regulations* (10 CFR), "Requirements for Renewal of Operating Licenses for Nuclear Power Plants." As a potential respondent to this information collection, we are interested in your feedback. Specifically, we are seeking input on the following questions by July 19, 2021:

4. How can the burden of the information collection be minimized, including the use of automated collection techniques or other forms of information technology?
