1. In accordance with reference (a) NRC has agreed to provide support services to the Naval Sea Systems Command (NAVSEA) and the Naval Nuclear Propulsion Program (NNPP) to facilitate the decommissioning of the Navy Surface Ship Support Barge (SSSB).
2. As part of the reference (a) scope of work, NRC is to review the Decommissioning Work Plan (DWP) developed by the disposal contractor (APTIM) and provide a recommendation to NAVSEA whether to approve this plan.
3. NRC provided a technical evaluation report on the contractor's DWP in reference (b), recommending NAVSEA approval.
4. Based on the evaluation in reference (b), NAVSEA approved the SSSB disposal contractor's DWP in reference (c), which is included as Enclosure (1) to this letter.
