Subject: Training provided to F&R staff regarding the May 20, 2021, NOV

Discussion: I informed Mr. Clarke that F&R's Reply to the May 20, 2021, Notice of Violation (NOV), did not summarize the information conveyed or training delivered to portable gauge users in response to NRC's May 20, 2021, NOV. Mr. Clarke stated that he communicated the expectation to all site RSOs that all portable gauge users who transport portable gauges must install chains according to the laminated procedural guidance provided to all gauge users, and that guidance requires each gauge user to use the correct length of chain, the correct gauge of chain, and the correct type of lock, and that each site RSO is responsible for delivering that information to their staffs.

Action Required: I will reference that information in the Reply to NOV Acknowledgement letter.
