Hi Tracy,

A few weeks back we received the attached initial notification of a Deviation Identified in the Bolting Utilized to Maintain Seismic Qualification of certain chillers. As you know, the NRC tries to publish all Part 21 reports to our public website in order to increase stakeholder knowledge of events and to better promote reactor safety. Unfortunately, we cannot publish the attached deviation at this time. This is related to verbiage found on the email cover sheet, which states:

**“Confidentiality Note:** The information contained in this message (and attachments) **is**

**confidential** and may be legally privileged. The message is intended solely for the addressee(s). If you are not the intended recipient, you are hereby notified that any use, dissemination, or reproduction is strictly prohibited and may be unlawful. If you are not the intended recipient please contact the sender by return e-mail and destroy all copies of the original message and attachments.”

The NRC cannot publish confidential material to the public website. If this material is indeed confidential, then I call your attention to Title 10 Part 2 of the Code of Federal Regulations, which in 10 CFR § 2.390 which addresses the requirements of Public inspections, exemptions, requests for withholding.

Now that said, over my many years at the agency I have discovered that about 99.999% of the time happens it is because someone grabbed a fax or email cover sheet with ‘boilerplate’ verbiage to the effect that the report is confidential. It usually isn’t, and I think that this is the case here too, but unfortunately extra work is required on our part to rectify this situation before we publish the report.

This is how I recommend we handle the case that this report is not in fact confidential. Please provide us with a email message stating that the information in the subject deviation report is not confidential, and then give us authority in the subject email cover sheet to strike out the words ‘**is confidential.**’ We will place your directing email message in ADAMS and cite this as the reference for striking the confidential statement on the email cover sheet. That should take care of this report

Please let me know when to proceed.
