
This letter is to inform you that Global Gauge Corporation has recently taken possession of one (1) radioactive Sealed Source Device from Berlin Metals in Hammond Indiana. This was performed under Reciprocity with the NRC initially filed on NRC Form 241 on January 26, 2021, and updated in a filing on May 3, 2021. Global Gauge Corporation operates under a Radioactive Materials License from the State of Ohio, License # 03214580001, Amendment number 7.

The following Source Device was removed by Global Gauge from Berlin Metals on Thursday, May 6, 2021, and is now in possession of Global Gauge Corporation. It should be removed from Berlin Metal's registration:
