Subject: Termination Procedure for License

Discussion: I examined the e-mail string between Mr. Andersen of Formosa Plastics and Nadine Aridi of NRC Headquarters of June 10th, 2021 through June 23, 2021. In it Ms. Aridi indicated that there were two invoices outstanding on the specific license and that the general license was inactive and did not have any invoices. Mr. Andersen responded that he believed that the license had been terminated and supplied an e-mail string between himself and Donald Lowman, NRC Headquarters as confirmation. The e-mail string does show Mr. Andersen asking if he supplied enough information to terminate the license and Mr. Lowman did indicate that was so. The e-mail string does reference the specific license.

I contacted Mr. Andersen and informed him that the specific license had not been terminated despite the assurances from Mr. Lowman. I explained how Mr. Lowman was based out of headquarters in Rockville, MD and was responsible for devices distributed under a general license. He had received enough information to terminate the general license for the 49 gauges but did not inform Region I that the licensee wanted to terminate its specific license. The regional offices had responsibility for issuing specific licenses of which NRC License No. 07-20540-01 was one. In order to terminate a specific license a NRC Form 314 must be completed or a letter containing the information required by the form. The information must be sent to the regional office by regular mail, fax, or e-mail to R1DRSSMail.Resource@nrc.gov. Since all 49 gauges possessed by the licensee were under general license; then, the form can be marked as no specific licensed material was possessed. All gauges were under General License # 52864. If he has any questions regarding the invoices for the specific license; then he should speak to Ms. Aridi or one of her associates.

Action Required: Document for future termination request.
