Dear Mr. Rhoades:

The Region I Field Office, NRC Office of Investigations (OI), initiated an investigation (Case No. 1-2019-012) on August 10, 2020, to determine whether a contracted cybersecurity specialist was discriminated against for raising nuclear safety concerns, while employed by Atom Logic, LLC, and working at Calvert Cliffs Nuclear Power Plant. Based upon documentary and testimonial evidence developed during the OI investigation, the NRC did not substantiate that the contracted cybersecurity specialist was discriminated against for raising nuclear safety concerns.

Please note that final NRC investigation documents, such as the OI report described above, may be made available to the public under the Freedom of Information Act (FOIA) subject to redaction of information appropriate under the FOIA.
