Enclosed is Amendment No. 28 renewing Hannibal Regional Hospital's (your) U.S. Nuclear Regulatory Commission (NRC) Materials License No. 24-18988-01 in accordance with your May 21, 2021 renewal application, including to address your March 24, 2021 request to add you as the listed Radiation Safety Officer (RSO) and to add J. Edward Bass, M.D. as an authorized user for materials permitted under 10 CFR 35.100, 35.200, and 35.300 on your radioactive materials license. Your renewal application and amendment request are available electronically from the Agencywide Documents Access and Management System (ADAMS) at Accession Nos. ML21091A013 and ML21144A073, respectively.

Please review the enclosed document carefully, and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. NRC Region III Office at 630-829-9892 so that we may provide appropriate corrections and answers.

An environmental assessment for this action is not required because this action is categorically excluded under Title 10 of the *Code of Federal Regulations* (10 CFR) 51.22(c).

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation; or imposition of a civil penalty; or an Order suspending, modifying, or revoking your license as specified in the NRC Enforcement Policy. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance that NRC expects of its licensees.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's expectations for individuals and organizations to establish and maintain a positive safety culture.
