SUBJECT: WITHDRAWAL OF NOTICE OF VIOLATION (IA-20-018)

Dear Mr. Sprinkle:

This refers to the investigation completed on May 17, 2019, by the U.S. Nuclear Regulatory Commission's (NRC) Office of Investigations (OI) at Tennessee Valley Authority's (TVA) Watts Bar Nuclear (WBN) Plant. The purpose of the investigation was to determine whether TVA employees deliberately submitted incomplete and inaccurate information to the NRC and whether TVA employees deliberately violated plant procedures. The investigation included the review of your actions regarding TVA's procedural change process at WBN Unit 1 in November 2015.

On November 6, 2020, the NRC issued you a "Notice of Violation, Nuclear Regulatory Commission Office of Investigations Report No. 2-2016-042" (Notice) (Agencywide Documents Access and Management System (ADAMS) Accession No. ML20310A419). The Notice documented that on November 9, 2015, you engaged in deliberate misconduct in violation of 10 CFR 50.5, "Deliberate Misconduct" which caused TVA to be in violation of TVA Procedure NPG-SPP-01.2.1, "Interim Administration of Site Technical Programs and Procedures for Watts Bar 1 and 2," Rev. 0002. Activities governed by this quality-related procedure must be performed in accordance with the procedure, pursuant to Title 10 of the *Code of Federal Regulations* (CFR) 50, Appendix B, Criterion V, "Instructions, Procedures, and Drawings."

Upon further review of the facts of your case, the NRC now concludes that although a violation of TVA Procedure NPG-SPP-01.2.1 occurred, your actions related to that violation did not constitute deliberate misconduct. Accordingly, we are withdrawing the Notice dated November 6, 2020.

You are not required to respond to this letter.
