The inspection schedule is provided in advance to minimize the resource impact on your staff and allow for the resolution of any scheduling conflicts and personnel availability issues, well in advance of inspector arrival onsite.

Please note that any regional initiative or other reactive inspection is not included in the schedule. Additionally, the NRC is currently updating the inspection program for Category II fuel cycle facilities and plans to implement that inspection program at your facility during calendar year 2022. The NRC will notify you in a separate letter with an updated schedule of inspections when the Category II inspection program has been finalized. If circumstances arise which cause the NRC inspectors to change the dates of the planned inspections, we will contact you to discuss the change as early as possible.
