This refers to your license amendment request dated April 15, 2021. Please find enclosed Amendment No. 34 removing the sealed sources and location of use at Braxton County Memorial Hospital (BCMh), 100 Hoylman Drive, Gassaway, West Virginia. Please note that this amendment is being issued concurrently with adding the sealed sources and the BCMh location of use to Summerville Regional Medical Center's license (NRC License No. 47-31126-01), which is being processed under mail control number 625488.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license.
