Dear Mr. Talavera:

This refers to your license amendment request dated April 9, 2021. Please find enclosed Amendment No. 22 removing authorizations for 10 CFR 35.400 activities, as well as the associated Authorized Users and facilities. Radiation Oncology areas referenced in your letter dated August 29, 2011, and the mold room referenced in your letter date March 14, 2012, may be released for unrestricted use. Please note that your request to remove Dr. Shafique from the license could not be completed because Dr. Shafique has not been listed on your license since the issuance of Amendment No. 19 on April 5, 2012.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. You will be periodically inspected by the NRC. This could include issuance of a Notice of Violation, or Imposition of a Civil Penalty, or an Order Suspending, Modifying or Revoking Your License as specified in the NRC Enforcement Policy.
