Please find enclosed Amendment No. 96 to NRC License No. 11-27312-01 adding three additional procedure rooms to be available as Authorized Use Areas at your facility located at St. Luke's Cancer Institute – Magic Valley, 725 Pole Line Road West, Twin Falls, Idaho for infrequent administrations of Xofigo (Ra-223), and authorization use of Cesium-131 permitted by 10 CFR 35.400, as requested in your letter dated April 20, 2021. An environmental assessment for this action is not required since this action is categorically excluded under 10 CFR 51.22(c).
