Levine, M.D. as an authorized user for 10 CFR 35.100, 35.200, and 35.300; and removing David Abramowitz, M.D., James Baek, M.D., Mary Elizabeth Far, M.D., and Mohammed Y. Haffar, M.D. as authorized users.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
