On June 29, 2021, from 5:00 p.m. to 6:00 p.m. (CDT), a public webinar was held by representatives of the U.S. Nuclear Regulatory Commission (NRC) to provide the public with information on the 2020 End-of-Cycle plant performance assessment of the Dresden Nuclear Power Station, Units 2 & 3 and Quad Cities Nuclear Power Station, Units 1 & 2, along with general information on the NRC. The NRC representatives discussed plant performance with members of the public and state government employees. Representatives from Exelon Generation Company were also in attendance.

The NRC discussed their assessment of Dresden Nuclear Power Station and Quad Cities Nuclear Power Station as documented in the March 4, 2021, End-of-Cycle Assessment Letters (ADAMS Accession No. ML21060B588 and ML21060B590, respectively). During the Question and Answer session of the webinar, representatives from the NRC discussed various topics of public interest.
