Mr. Burrus,

In accordance with the Settlement Agreement associated Office of the State Engineer File Nos.:1605 and B-28 and issued October 31, 2016, Homestake Mining Company of California (Homestake) hereby submits the June 2021 data as required by Proposed Conditions of Approval item 2. A summary of the required reporting is provided below.

A total of 35,825,900 metered gallons (109.9 acre-feet) were injected into wells in the San Mateo alluvial aquifer and the Upper and Middle Chinle aquifers, all located in Sections 26, 27, 28, 34 and 35 T12N, R10W and Section 3 T11N, R10W (Table 1). As stated in File Nos. 1605 and B-28, Homestake requests return flow credits for water that is returned to underground aquifers. A portion of this injected water was shallow aquifer water treated by reverse osmosis and zeolite.

A monthly total of 48,579,620 metered gallons (149.1 acre-feet) of water were pumped from Homestake's production wells, of which 35,825,900 metered gallons were returned to the Bluewater underground water basin (Table 1). Metered water usage for industrial purposes was 12,753,720 gallons (39.1 acre feet) for June (Table 1).

On June 28, 2021, the meter readings for Deep Well #1 (B-28-S), Deep Well #2 (B-28-S-1) and well 951R (B-28-POD1340) were 541,737,984, 956,982,000 and 849,480,000 gallons, respectively. Monthly meter readings and volumes of water used are presented in Table 2.
