The U.S. Nuclear Regulatory Commission (NRC) has prepared a draft environmental impact statement (DEIS) related to its review of Westinghouse Electric Company, LLC's (WEC) application to renew its operating license for the Columbia Fuel Fabrication Facility (CFFF) in Hopkins, South Carolina. The DEIS provides the NRC staff's evaluation of the potential environmental impacts of the proposed license renewal.

We are providing seven hard copies of the DEIS to the Richland Library per the conversation with the NRC staff on July 7, 2021. As discussed, one copy is for the Main Branch and three copies will be provided by you to each of the Eastover and Lower Richland Branches to be maintained as reference documents at the library.
