This letter concerns your request to amend your U.S. Nuclear Regulatory Commission (NRC) License No. 37-30120-01. In your letter dated April 20, 2021, you requested to add a location of use at the James E. Van Zandt VA Medical Center in Altoona, Pennsylvania. Your amendment request is available electronically from the Agencywide Documents Access and Management System (ADAMS) at Accession No. ML21124A211.

It was determined that the James E. Van Zandt VA Medical Center in Altoona, PA falls under concurrent (non-exclusive federal) jurisdiction, and the appropriate regulatory agency is the State of Pennsylvania. Based on this understanding and your letter dated July 21, 2021, you informed us that you no longer need the requested action and you are withdrawing the amendment request. Therefore, we have administratively closed your license amendment request.
