This refers to your license amendment request dated May 27, 2021. Please find enclosed Amendment No. 21 removing Dr. Nazario and the authorization to use Yttrium-90 SIR-Spheres under your license. Please note that in order to conduct Yttrium-90 treatments in the future, an amendment to your license must be made.

An environmental assessment for this action was not required since this action is categorically excluded under 10 CFR 51.22(c)(14).
