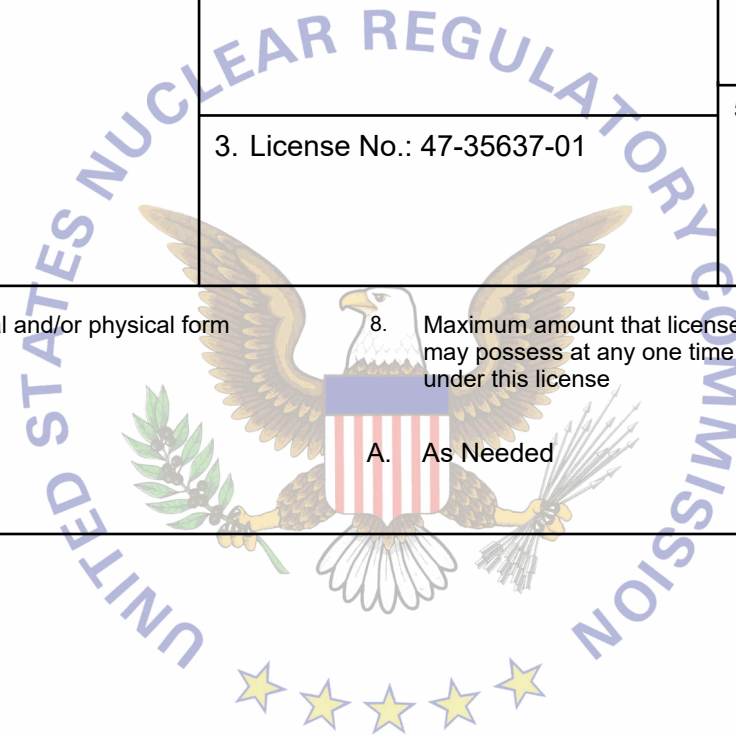


U.S. NUCLEAR REGULATORY COMMISSION

## CONDITIONS

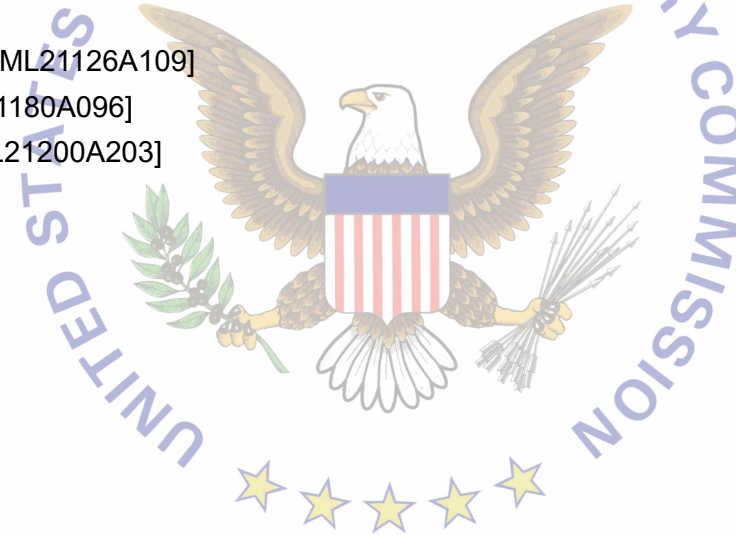
10. Licensed material shall be used or stored at the licensee's facilities located at: 818 North Eisenhower Drive, Beckley, West Virginia, 25801
