Dear Mr. Smith:

This letter concerns the subject request to amend your U.S. Nuclear Regulatory Commission (NRC) license No. 31-31284-01. You have requested to amend license condition 13.A to allow for leak tests to be conducted at 12-month intervals for the portable gauge models currently authorized on your license. Your request is available electronically from the Agencywide Documents Access and Management System (ADAMS) at Accession No. ML21201A110.

As discussed during our telephone conversation on July 21, 2021, we have determined that your license currently authorizes the requested activity such that an amendment to the license to authorize the activity is unnecessary. Specifically, the registration certificates for each model currently authorized on your license authorizes leak test frequencies of 12 months. In accordance with our communication and in accordance with your letter (ML21208A017) dated July 21, 2021, we have noted that you have confirmed that the license amendment request should be withdrawn. Therefore, the referenced request has been administratively closed.
