The purpose of this letter is to provide American Centrifuge Operating, LLC's (ACO) responses to the U.S. Nuclear Regulatory Commission's (NRC) requests for clarification. Additional information is provided as Enclosure 1. Enclosure 2 provides the supplemental proposed changes to security plan SP-3605-0043, *American Centrifuge Operating, LLC Classified Distributed Control System (DCS) Information System Security Plan (ISSP)*. Supplemental proposed changes are noted in green highlights.

On July 16, 2021, staff from the NRC and ACO held a conference call to discuss clarifications needed in relation to ACO's DCS ISSP submittals dated April 1, 2021 (Reference 1) and June 22, 2021 (Reference 2).
