This refers to your license amendment request dated June 11, 2021. Please find enclosed Amendment No. 8 authorizing the requested change in Radiation Safety Officer (RSO). Additionally, your authorized materials have been separated by manufacturer. Finally, the Sealed Source and Device registration for the Troxler Electronic Laboratories Model 3400 Series now covers Troxler Electronic Laboratories Model 3411 gauges. As such, Troxler Electronic Laboratories Model 3411 was removed from your license and included in the authorized quantities under the Troxler Electronic Laboratories Model 3400 Series.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. You will be periodically inspected by the NRC.
