Dear Ms. Sterdis:

On August 10, 2021, the U.S. Nuclear Regulatory Commission (NRC) completed both an Independent Spent Fuel Storage Installation (ISFSI) security inspection and a decommissioning security inspection at the permanently shut down Oyster Creek Nuclear Generating Station (Oyster Creek) in Forked River, New Jersey. On-site inspection was conducted from August 9 - 10, 2021. The ISFSI inspection covered the licensee's physical security plan, Revision 0 and NRC Order EA-02-104 dated October 16, 2002, "Additional Security Measures." The ISFSI inspection was conducted using NRC Inspection Procedure 81311, "Physical Security Requirements for Independent Spent Fuel Storage Installations." The decommissioning inspection covered the licensee's physical security plan Revision 21 and was conducted using NRC Inspection Procedure 81200.02, "Access Control for Decommissioning Nuclear Power Reactors."

The enclosed inspection report documents the inspection results, which were discussed with Mr. Jeffrey Dostal, Site Vice President, and other members of your staff, on August 10, 2021.

The inspection examined activities conducted under your license as they relate to security and compliance with the Commission's rules and regulations and with the conditions of your license. The inspectors reviewed selected procedures and records, observed activities, and interviewed personnel.

Based on the results of this inspection, the inspectors documented three violations of very low security significance, Severity Level (SL) IV, involving violations of NRC requirements in this report.
