Enclosed is Amendment No. 32 to your U.S. Nuclear Regulatory Commission (NRC) Materials License No. 24-24576-01 in accordance with the requests dated July 12, 2021 and August 11, 2021, both signed by Rick Thompson, Radiation Safety Officer and Safety Engineer.

The license has been amended to reflect your appointment as Radiation Safety Officer. Further, the reference to the Model ATK 2010 gauging devices have been updated in alignment with the amendment to U.S. NRC Sealed Source & Device Registry Sheet #NR-1336-D-101-S, dated February 22, 2021. This amendment now identifies Olin Winchester, LLC, as the manufacturer/distributor and custom user of the Model ATK2010 gauging devices.
