This refers to your license amendment request dated July 12, 2021. Please find enclosed Amendment No. 64 removing 10 CFR 35.400 uses and the requested authorized users. As discussed with Mr. Ian Crooks, Director of Physics, today, we understand that the last manual brachytherapy patient was implanted with seeds on April 3, 2013, with all seeds implanted and no seeds remaining on-site.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. You will be periodically inspected by the NRC.
