Dear Mr. FitzPatrick:

This is in reference to your letter dated August 19, 2021, requesting to amend NRC License No. 06-28529-01. In order to continue our review, we need the following additional information:

1. Your August 19, 2021, letter requested that Mr. Ryan Beauregard be approved as your new Radiation Safety Officer (RSO). Your letter included an attestation of technical competency and indicated that Mr. Beauregard had completed RSO training. Please provide a copy of the RSO training certificate or authorized user training certificate in accordance with Item 7 of Appendix B in NUREG-1556, Volume 1, Revision 2, "Consolidated Guidance About Materials Licenses: Program-Specific Guidance About Portable Gauge Licenses". The NUREG guidance may be found at the following address: <https://www.nrc.gov/docs/ML1617/ML16175A375.pdf>.
2. Awareness only, no response required - Your amendment request letter indicated that Mr. Beauregard was replacing Mr. Brett Grunert as the RSO. However, your current license amendment, Amendment No. 11, lists Mr. Peter Falce as the RSO. This will be reviewed in your upcoming routine inspection.

In order to continue prompt review of your application, we request that you submit your response to this letter within 15 calendar days from the date of this letter.

You must list all portions that you wish to be held proprietary, along with your reasoning as to why that is appropriate. While it is allowable, please refrain from submitting proprietary information in support of a license unless necessary. Keep in mind that all NRC licenses are considered to be in the public domain, and therefore may be viewed by any member of the public who requests to see them.
