Dear Mr. Rhoades:

By letter dated September 15, 2021 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML21258A281), Exelon Generation Company, LLC (Exelon) informed the U.S. Nuclear Regulatory Commission (NRC) that it had reversed its decision to permanently cease power operations at Dresden Nuclear Power Station, Units 2 and 3 (Dresden), as previously communicated to the NRC by letter dated September 2, 2020 (ADAMS Accession No. ML20246G627). Accordingly, Exelon requested that the following docketed licensing actions be withdrawn:

1. Exelon letter dated September 24, 2020, "License Amendment Request – Proposed Changes to Unit 1 Technical Specifications Section 6.1, 'Responsibility,' and Units 2 and 3 Technical Specifications 1.1, 'Definitions,' and 5.0, 'Administrative Controls,' for Permanently Defueled Condition" (ADAMS Accession No. ML20269A404) (EPID L-2020-LLA-0217);

3. Exelon letter dated October 29, 2020, "License Amendment Request – Proposed Defueled Technical Specifications and Revised License Conditions for Permanently Defueled Condition" (ADAMS Accession No. ML20303A313) (EPID L-2020-LLA-0239);
4. Exelon letter dated November 2, 2020, "License Amendment Request – Proposed Changes to Dresden Emergency Plan for Post-Shutdown and Permanently Defueled Condition" (ADAMS Accession No. ML20307A434) (EPID L-2020-LLA-0237);

8. Exelon letter dated July 28, 2021, "Dresden Nuclear Power Station, Units 2 and 3 - Post-Shutdown Decommissioning Activities Report" (ADAMS Accession No. ML21209A027) (EPID-2021-LRO-0040).

The NRC has forwarded the enclosed notices of withdrawal regarding the above, previously noticed three applications for amendments to the Dresden amended and renewed facility operating licenses to the Office of the Federal Register for publication.

The NRC has granted the request of Exelon to withdraw its application dated October 29, 2020 (ADAMS Accession No. ML20303A313) for proposed amendments to Renewed Facility Operating License Nos. DPR-19 and DPR-25 for Dresden, Units 2 and 3, respectively, which are located in Grundy County, Illinois. Exelon is the licensee that owns and operates Dresden. The proposed amendments would have changed the Dresden TSs to permit changes in plant operations when the plants are permanently shut down and defueled. Specifically, the proposed amendments would have revised the Dresden renewed facility operating licenses and TSs following the permanent cessation of power operations to reflect the post-shutdown and permanently defueled condition of the units. The proposed amendments would have eliminated TS requirements and license conditions that would not have been applicable once Dresden

ceased power operations and could no longer place fuel in the reactor vessels. The proposed amendments would have also eliminated obsolete license conditions. Additionally, the proposed amendments would have revised several license conditions and TS requirements, including limiting conditions for operation, usage rules, definitions, surveillance requirements, and administrative controls. The licensing bases for Dresden, including the design bases accident analysis, would have also been revised.

The Commission previously issued a proposed finding that the proposed amendments involve no significant hazards consideration published in the *Federal Register* on January 26, 2021 (86 FR 7117). However, by letter dated September 15, 2021 (ADAMS Accession No. ML21258A281), Exelon requested to withdraw the proposed amendments.
