We have added Charles A. Wilson, IV, Ph.D. as an Associate Radiation Safety Officer for your license in new Condition 11.B. Please note the parameters of this new authorization as the Associate RSO position is only defined for limited scope medical use licensee in 10 CFR 35.2.

This amendment also resulted in an adjustment to Subitem No. 33.ZI and the addition of Subitem No. ZL.

We noted that a direct phone number for Dr. Wilson was not provided in your amendment request letter dated June 7, 2021. Dr. Wilson's doctoral degree was not described as a "Ph.D." in this letter either. Ideally, a copy of a proposed ARSO's terminal degree is helpful.

In a future amendment, please provide a direct telephone number for Dr. Wilson.
