SUBJECT: CLOSURE OF INVESTIGATION (OI 4-2020-007)

Dear Mr. Giddens:

This refers to an investigation conducted by the U.S. Nuclear Regulatory Commission's (NRC's) Office of Investigations, regarding activities at Arkansas Nuclear One. The Office of Investigations initiated the investigation to determine whether contract employees at Arkansas Nuclear One deliberately provided incomplete and inaccurate information regarding the completion and performance of a work order for the removal of intermediate cooling water spring can gags.

Based on the evidence developed during this investigation, the NRC substantiated that contract employees at Arkansas Nuclear One deliberately provided incomplete and inaccurate information regarding the completion and performance of the work order. However, the willful actions did not result in a violation of Title 10 of the *Code of Federal Regulations* (CFR) or any other NRC requirement. The NRC plans no further action related to the willful aspect of this allegation and considers this investigation closed.
