The Agency has finalized Rule 420-3-26-.02, Licensing, 420-3-26-.07, Use of Radionuclides in the Healing Arts and 420-3-25-.15, Physical Protection of Category 1 and 2 Quantities of Radioactive Material. There were no public comments received for these rules. In their meeting on September 15, 2021, the State Committee on Public Health approved the final version of these rules. They will be published with an effective date of November 14, 2021. Copies of the final rules will be sent electronically.
