**ACCEPTANCE:** Individuals listed in Enclosure 1 have been accepted for participation in the Irradiator Technology (H-315) course. This course is scheduled to be presented November 2-4, 2021 at the Nuclear Regulatory Commission (NRC) Region IV Office. **COURSE:** Please see our Web site, <http://scp.nrc.gov/training.html> for the Tentative Course Schedule and note that the course begins at 8:00 a.m. central time on Tuesday, November 2nd and ends at 3:00 p.m. central time on Thursday, November 4th.

**LODGING AND TRAVEL:** Please plan to arrive on Monday, November 1st, and depart on Thursday, November 4th. Students must make their own lodging and travel arrangements. If there are no flights available that would allow you to arrive home before midnight on Thursday, November 4th, you may elect to depart on Friday, November 5th. In this event, NRC will provide reimbursement for hotel on Thursday night and per diem on Friday, November 5th. If traveling by air, please contact El Sol Travel at (844) 244-6694 for airline reservations and indicate that the travel is "Invitational" for the NRC. Please select a fully refundable government fare if one is available, and make sure that El Sol Travel correctly direct bills your fare to the NRC. If the need arises and you must make a change, contact Karen Meyer at (301) 415-0113.

Please complete the Travel Application Form which will be provided to you and submit to [ASTrainingandtravel.Resource@nrc.gov](mailto:ASTrainingandtravel.Resource@nrc.gov), at your earliest opportunity, but no later than Friday, October 22nd. Individuals should request the Federal government rate at the hotels. The per diem for Arlington, TX is \$167 for hotel and \$61 for meals and incidentals. The first and last day of travel is calculated at 75 percent. If you are authorized to drive, the Federal mileage reimbursement is 56 cents per mile. Rental cars are not authorized for reimbursement.
